### Age Groups

**Session 1**—for ages 4–12 will be held on December 8th, 10th, 15th and 17th from 6:00–7:00. Fee is \$35.00. A \$10 discount will be applied for 6–12 year olds who are already registered for the 2010 TCSC spring season

**Session 2**—for ages 13–18 will be held on January 12th, 14th, 19th and 21st from 6:00–7:30. Fee is \$45.00. A \$15 discount will be applied for 14–18 year olds who played for TCSC during the 2009 fall season.

Camp Fees include a camp t-shirt.

### Location

Camp will be sessions will be held at either Hurricane Park or just down the road at Wren Elementary School.

### What to Bring

Players should dress in athletic attire that is appropriate for challenging activities and cooler winter temperatures, wear shin guards and soccer shoes, and bring a well-marked soccer ball. Access to water will be available, but players should bring a water bottle and refill if needed.

### Registration

Registration will open on November 15th and will end one week prior to the start of camp or when the camp is full. An administrative fee of \$15 will be deducted from all refunds. Refunds after January 8th will be issued only at the discretion of camp administration.
